Application form (found in the main webpage of the Modern Greek Language Teaching Centre). Submitted ONLY electronically2. High School Diploma or University Degree, verified for the authenticity of the title by a Greek Diplomatic authority abroad or by the Diplomatic authority of the foreigner's country in Greece or stamped with the Apostille seal in accordance with the Hague Convention (see appendix) and officially translated into Greek by a Greek Diplomatic authority abroad or by the Translation Services of the Ministry of Foreign Affairs (10 Arionos str., tel.: +30210-3285756, +30210-3285757) or by a lawyer with verification by the Lawyers' Bar. Scholarship holders or those who have been accepted for studies by Ministries, Institutions or Public Schools of Higher Education must attach the appropriate certification only3. Passport or ID card for European Union citizens. Moreover, for students who originate from countries which are not members of the EU, a residency permit which covers the entire duration of the course is NECESSARY4.
